## THE CASE

BRFKredit wished to transition from SAP to Microsoft Dynamics AX. As part of this, BRFkredit expected the implementation of Dynamics AX 2012 R2 in both test-and productionenvironments, including administration to allow accounting, as well as finance.

Furthermore, both inbound and outbound interfaces for specific BRFkredit business partners had to be established, users had to be educated in the use of modules as was deemed relevant to their function and super users were educated in interfaces and follow-up.

The implementation included a total of over 120 users of multiple types, when the system is fully implemented in spring/summer of 2014, and it was important to BRFkredit that the implementation took their company structure into account to allow for future consolidation.

BRFkredit also voiced expectations that the implementation would fit into a .net strategy, and that electronic invoicing worked smoothly.

## THE SOLUTION

In concrete terms, this means that BRFkredit will experience a far higher Return on Investment (ROI) by choosing Dynamics AX. BRFkredit will also be paying less maintenance and subscription fees by choosing Dynamics AX than they would have with SAP. BRFkredit requires a system that is easy to use, and Microsoft

Dynamics AX has a well-deserved reputation for ease-of-use in comparison to SAP, with an interface that is designed to be both easy to master and to remind users of the Microsoft Office package that most SAP users are already familiar with, with seamless integration between Dynamics AX and other Microsoft products.
